# 2. Minutes of the previous meeting

# 3. Matters arising

- 4a) We are still awaiting our £100 from the Council in respect of the cost of the Bulb Planting exercise.
- 4d) N.S.S. head office replied in writing indicating that prizes would be donated by the store upon showing the letter to the Manager; This was borne out in practice.
- 6b) Two tackets for the hen night have so far been sold. We stand to lose £250. We have until next week to decide whether to cancel.
- 11) The bottle of Scotch is to be purchased shortly.

## 4. Chairman's Report / Correspondence - Peter Winter

# a)GYLD:

Letter from Mark Atkinson dd6th Jan. indicating that they might participate in the Gala. See item 10.

#### b)Finance for Centre:

Letter from R. Cook(solicitor) reminding us of the consequences if we fail to raise the required funds in time

#### c) Health and Housing Sub-Committee: (Drop in Centre)

Meeting held on 15 Dec. They were very sympathetic towards the Park. Impressed by our initiative / offer. Meeting 7th Jan. we are top of the poll re priority. Mr Elston will find the money for a temporary sight during the next financial year.eg the old community sight next door to the Church near to Waitrose. The needs of other groups on the Park was mentioned and suitability of a joint centre would become be investigated.

# d) Senior Citizens:

Letter to the press sent requesting volunteers to help Senior Citizens with their shopping, particularly in the winter months. The Chairman asked to be kept informed of all letters / action taken by members of the Committee involving the Association so that he could 'Be Prepared'.

#### e)Leaflets:

The Chairman referred to political leaflets in his possession which had been circulating around the Park. As an independent organisation he objected to the Tit-for-Tat arguments/articles therein.

#### 5.Treasurer's Report

No report was submitted as the Treasurer was not present. (Held up in London)

# 6. Social Sub-Committee Report - Brian Bailey

# a) Children's Christmas Party:

73 'Boisterous' children enjoyed themselves although the same could not be said for the helpers. 7 & 8 year olds were identified as the trouble makers. Name badges were suggested for next year to make identification easier at present time. Some parents had still not arrived to collect their charges 20 minutes after the official end although it was acknowledged that perhaps we were more punctual than usual.Mrs P.Heath wrote a very nice thank you letter and said she'd join the Association on the strength of the party.

# b) Jumble Sale:

This Friday evening and Saturday a.m. jumble will be sorted at Sythwood school ready for the doors to open at 1.30 pm Saturday. Admission 10p.

# c)Hen night:

See earlier reference (3-6b). We must sell 50 tickets to break even. The event is again advertised in this month's newsletter and there will be an article in this week's Review.

# d) Valentine dance:

The committee was encouraged to attend. Tickets £4, £4.50 for non-members. Barbara is in charge of the food.

# e)Stag night:

Tickets £5.00 and £4.50 On sale from Brian now.

#### f)Miscellaneous:

3 Jumble sales and perhaps another hen night were in the pipeline for the remainder of the year. The "free" disco would be a 60's/70's music night but no theme as such. £3 and £3.50. Car boot sale 29/4 confirmed. 3 other car boots to be arranged during the year.

# g)Letter from secretary:

Rachel had earlier suggested various fund raising/
social events for consideration by the social sub-committee. Beautiful Baby
contest could be part of the gala- Moss Bros to sponsor. Jumble sale specially
for babies/maternity wear etc- demand would not be great enough. The youth
activities already fall under M.A's jurisdiction. The importance of involving
the disabled and senior residents on the park was discussed; again, a
glamorous granny contest could be part of the gala. The carol singing idea
was welcomed and the possibility of ousting the round table from their perch
outside Waitrose was mooted; perhaps we could decorate a float- Andy Knowles is
to be approached. We have attempted 2 previous art and craft fares; only
one was a success.

# h)Other possible events:

Cat show. film show— to be held in abeyance until centre is operational. Horse racing evening ditto. Perhaps more social and less fund raising events could be arranged after March once the cheque could be covered. A new coach operator, Mr Galean, is to be seen re possibility of him being able to fill a coach if we could fill only 10/15 seats.

#### i) Miss Goldsworth Park:

New sponsor required to replace Frazers. Bridgers and Mann & Co. were approached by Peter and Brian respectively. We require £3400(£1000 sponsorship and support of the newsletter) Bridgers offered us £3100 initially but quickly increased it to £3400 when we declined. Plus they said they had the opportunity to obtain furthur sponsorship for us from their associate companies. Later advised they had one lined up and 2 more in the pipeline. Mann's first offer was for £3400 - have not had the opportunity to improve on that if they are able. The Committee were asked to choose between them. After a lively discussion the final vote was as follows; Bridgers....4 votes

1 abstention.

It was decided that Peter and Brian were to continue their negotiations and to settle on the best deal for the Park without the need to return to the Committee

j)Gala:Mark Atkinson was asked to address the meeting.

GYLD were considering a youth rally/ event in combination with the gala. 14+ age group including youth clubs, Church, sport clubs etc. It's a knockout style was envisaged &/or obstacle race, 3- legged, etc but no firm ideas yet. We had been thinking along the lines of an inter schools bash but along similar lines to the above. The event(s) would have to be held principally in the same arena. Deadline approx 2 months, Mark was therefore invited back to the March meeting.

#### k) Dash for the Centre:

Advance letters were ready. Pairs /areas had been allocated. The draw would take place in the Fine Fate store by Miss Goldsworth Park.

# 7. Newsletter Editor's Report - Brian Bailey

The layout had been revamped slightly. We lost money on the last 2 additions but this was usual owing to the Xmas break. Things will pick up now. The charge to the advertisers will inwrease. Prittles (double glazing) have contacted us. They will pay the Association  $2\frac{1}{2}$ % commission on all sales on the Park. No time limit. Will still pay for the advertising.

# 8. Community Centre- Peter Winter

We do not know what is going on as W.B.C is very uncommunicative. The Chairman related the saga concerning the signing and return of the building agreement and Council officers accusing the Association of holding matters up. This has culminated in a strongly worded letter from the Chairman to Mr John Alexander(vice Chairman of the leisure Committee) with copies to the 3 Park Councillors; John Covus has taken the matter up on our behalf.

# Justices On-License:

We have received a set of proposed conditions to be attached to the License. We have objected to some of these as being very restrictive/ not practical. Our complaints have been acknowkedged and there is a further meeting on 5 February - we may get some feedback.

# 9. Membership

Steve Dixon not present. A fair number of rejoining letters have come back. In answer to a question by John Sawtell it was confirmed that the Discount list for members was being updated.

#### 10 Any Other Business

The Chairman expressed his apologies for not mentioning this at the beginning; Mr R.Cook, Committee member, who was elected at the AGM suffered a heart attack 2 days later and died shortly afterwards. A card has been sent on our behalf.

The secretary had several items of correspondence to report:

- 1) political leaflets mailed directly to home address, (addressed to the association).
- 2) confirmation from Woking Borough Concil that the social centre had been booked for our monthly meetings for the rest of 1987.
- 3) letter from D Raynes of the Council advising of the proposed speed limits along Lockfield drive. Described by the Committee as unpractical, confusing and unenforceable. Our comments were required by 29 December 1986 (despite the Christmas break). Colin Grainger will phone the Council in the light of his previous monitoring here.
- 4) The secretary was pleased to report receipt of a cheque for £250 from Nat West, her employers. Peter signed a thank you letter and the Committee expressed their appreciation.

Barbara is waiting on the final numbers before finalising the food arrangements. Was suggested we canvass people/knock on doors. Hopefully an article in The Review this week.

e)Stag night:

35/40 tickets sold. Not making a profit yet but ticking over.(at end of February)

f)Treasure hunt:

26 April. £3 per car. 2/2½hour tour round Surrey countryside; end up in hostel.

g)Spalding trip:

No further forward as meeting had been cancelled but no problem envisaged.

h)Clothing Party:

Ex Marks and Spencers clothes and towels sold cheaply. 25p admission and we get 10% of takings. Hope to collect £1000 on a good evening. 3 April provisional at Knaphill Community Centre. Secretary to take forward.

i)New Events:

A skittle evening and barbeque were in the offing. Barbara knew someone to contact re Horse race evening; these were usually hard work. Colin Grainger is to take forward a watersports event for June /July. Lots of ideas were requested from the Committee. John Sawtell suggested a

fishing match on the lake - after 16 June. Permission? (From Bob Bennet)? £1 entry fee? Would be an all day effort.

Gary Baxter suggested a fun run. Woking Orbit organise one but usually do not make that much money. The Church held one recently.

# i)Miss Göldsworth Park:

£1500 from Manns. They are not too concerned how we spend it but have stipulated that they put up the whole of the first prize(£300 cash). W&P to donate £200 towards the cost of staging the evening. (For the Gala Mann will put up £300 and W&P £200. Mann will sponsor the fireworks at £400 and W&P the Xmas party at £500.) Have applied for the centre halls for 29 May and the organist has been booked. To be launched in the March Newsletter. Additional sponsors are required. Rose is 40° certain of obtaining a £50 travel voucher from Mogg Robinson. Problem finding the entertainment. Last year the dance troupe was pathetic. The Irish comedian was also weak. Have approached Wally Dent £100 single act. Do the Committee know of a good entertainer?

<u>j)Gala:</u>

Not too much success at the moment. Everything is booked/ not available already. Bouncy castles/rides, police and army, can't come. Guide dogs are uncertain. Minature trains not interested. Barbara is awaiting confirmation from the radio controlled cars. There may be a static display from ambulance, fire brigade.

Arthur is making steady progress re public address system.

The arena itself is full. We have a marching band and the youth contest. Outside it's pretty thin; ideas were called for and also for the procession.

# 7) Newsletter Editor's Report - Brian Bailey

Ready for delivery; can we do so promptly please. Further improvement in the layout this month; our events are delineated more clearly. Alot of interest from the advertisers at the moment. 1 or 2 of the 'bad debts' have paid up but still a couple outstanding.

### 8)Community Centre- Peter Winter

In response to The Chairman's letter (see 4b) The leisure Services Committee will meet monthly with us with the objective of answering any questions we may have. In our opinion many people have been misled; The architect asked for additional funds for the heating system but we now find that only individual gasfires will be installed, no central heating system, to keep the cost down.

The walls are to be plastered & emulsioned with spray fleck paint. False ceiling with recessed lighting (2.5m). The committee asked whether it could be raised; will be advised in due course.

The fire office has insisted on an additional fire exit. Gas heaters over the entrances may be installed.

Carpets: The Committee was asked to choose the colour carpet from a selection displayed by the Chairman. The carpet would be resistant to most types of stains. Also had to choose whether the carpet was to cover the whole area of the floor. If we did not like the selection in front of us we could choose an alternative subject to a price restriction of £9 a sq yard. (included in cost). After much discussion the Committee decided by 9 votes to 2 to carpet the whole area but purchase a portable dance floor at a later date if neccessary. The colour pebble was chosen in preference to copper by 9 votes to 2.

Walls: The colour will be chosen at a later date.

Power Points: The Committee were asked to choose the number and location of power points for the lounge, snug bar and office. Cable loading was important and we wanted to incur no extra cost here. It was decided that 6,2,2 double sockets respectively should be fitted but reduce to 4,2,2, if this could reduce the cost. Peter and Brian are to investigate the question of T.V.points

and cables. Therewill be one telephone in the Council manager's office. We might be able to get a spur but ,again, no extra cost is wanted. A payphone is different altogether.

Ceremony: The Mayor will be digging the first sod at 11am on 14/2/87. We are all invited to attend. Press will be contacted and Councillors informed. It is not known where the shovel will be obtained from . Miss Goldsworth Park is to be contacted.

Licensing application: Granted. However they would not modify the conditions previously discussed. In view of the prevarication of the bench we have incurred hefty legal expenses. John Alexander supported us here.

# 9)Membership - Steve Dixon

Of the 7/800 letters sent out only 30 have rejoined, barely covering our costs. We have 450 adult members, 250 senior citizens, 166 children, 430 households. After much discussion it was decided to allow new memberships to run to June 1988 (if joined between now and June). Existing memberships to be renewed in June 1987 to June 1988. Same fees as last year. The tear off slip is to be relocated to the bottom rather than the middle of a newsletter page. There is no limit to the membership of the Centre nor do we have to maintain a minimum membership of the Association in view of the grant from the County Council. Charity Commissioners may insist on a separate membership of the Centre to the Association itself. Golden membership is being dropped.

# 10) Any other business

# a) Drop in Centre:

Meeting at the Council last Monday attended by The Chairman, Andy Knowles, and Chris Edwards. The money is available as soon as we can negotiate a plot of land. A.K advised they were not now building a Church Hall due to lack of funds and a portion of his site was now surplus to requirements (in the short term.)

#### b)Furniture:

Arthur advised there was a surplus of tables and chairs etc in Lomdon classrooms. In good condition, The Chairman is to find a contact in ILEA re purchasing these for the Centre.

- c) A possible new Committee Member has been identified by Barbara and Cathy.
- d) Jenny Warner would like to buy a brick.

## e)Silversmiths Way garage:

The Committee agreed to meet the 1987/1988 rates bill (£18?) following receipt of a long letter from Mrs Prime(refer4h). Barbara will arrange for her gutters to be cleared.

#### f)Previous Minutes:

Chris Edwards advised that we required a license for carol singing outside Waitrose. However this had already been granted for 1987. The letter re the speed limits - deadline has been extended and we can still make representations. The overhanging vegetation outside Waitrose is to be cleared by the Council.

# a) Receipts / Payments Statement:

Miscellaneous £102.70 in respect of bulb grant from Council. Grand Draw means the Raffle Tickets. Valentine Dance made a disappointing £5 profit. The Stag Night made £73.57

# b)Statement of Financial Assets:

£17907.50 as at 28.02.87. It is estimated that we will have a working balance of approx £1100 after the £17000 has been paid over. We can survive but the next few months are always tight on cash flow. A large presentation cheque has been ordered from Barclays.

## c)Miscellaneous:

Jim Lane wished to know to what extent the raffle proceeds had been taken into account. Only a proportion so far; more monies were to come and be recorded.

We are expecting an invoice from our solicitor which will exacerbate matters.

# 7. Social Sub-Committee Report - Brian Bailey

#### b)Stag Night:

# i)Dash For The Centre: - Ken Nieman

The draw will take place on April 3rd in Fine Fare. A big thankyou was extended to everyone; the hit rate was better than expected but we are running out of time. The original costs of £370 were now believed to have been overstated by approximately £70.

The time of the draw is to be decided; we will sell tickets for 1/12 hrs on the night and the draw will hopefully be made by Miss Goldsworth Park. A

photographer may be present.

We have grossed £750/800 so far and 1200 books are still to be sold. We have a space to sell tickets at the store on 20 March 6-8pm and volunteers were obtained to man the stall. They will provide a table and we will arrange a display and hanner.

Not all the Park was scheduled to be covered and extra quotas could be provided if people had the time.

Martin Hall suggested that the scheme was chauvinistic; Brian advised that the evening was referred to as the 'Friday Spectacular'.

The Judges will be representatives from Mann & Co, Hogg Robinson, Florists, Whiteman & Packer and the Woking Review.

The donation from NSS is this year coming direct from Head Office and not the shop itself.

The event will be professionally videoed.

f) Firework display: Ken Nieman has been unable to get an answer from Reaufort school re use of their playing fields. Brian has written but remains sceptical. The lake was suggested as an alternative site but was rejected in view of difficulty in controlling access and uneven ground. Other sites were discussed but considered not suitable for a bonfire.

Or, as an incentive, the winning number drawn from those returned receives a prize. Martin Hall suggested that perhaps only 100 should be printed and committee members take a door to door canvass.

### j) Gala:

Brian may have a bouncy castle. Martin Hall gets them from Kenny's.

Friends of Sythwood school will run a beer tent for a donation. A drinks licence is being applied for.

We require prizes for the Gala draw. Colin Grainger has obtained £50 sponsorship from his employers; Rachel Webb is to approach her employers as is Rose Greig.

Barbara Springall is seeking sponsorship for the baby contests from Moss Baby shop. Barbara is also making a crazy golf set and requires guttering, pipes, and bits of wood.

Last year we charged 40p entrance fee, 20p children and senior citizens. In the light of comments received last year we are to charge 50p for adults this time and children and senior citizens are to be allowed in free. Stall holders will be charged £5, £7.50, £10 for advertising, non-commercial fund raisers and commercial stalls. Martin Hall advised that a charge of £15 commercial, £7.50 others was possible,

The 2 Beaufort schools were reluctant to take part in the youth events owing to difficulty re supervision. As Mark Atkinson works mainly with 11-18 year olds the events will consist of activities for this age group. There may be some impromptu events for the younger children on the day.

Martin Hall suggested obtaining sponsorship from local businesses in a programme; It was thought this would not be as successful with ourselves compared with the response usually received by schools. Martin will suggest some of his contacts to us so that it may be investigated further.

The arrangement would mean that the C lub would organise all the 'trading events' and pass all the profits to the Charity.

P.W highlighted the dangers of power slipping away from the Association to the club. R.C confirmed it was possible to draw up rules to help prevent this.

There is a clause in the lease allowing us to wind up the club after 2 years or pass a special resolution to become a registered club.

In answer to a question from P.W., R.C confirmed it would be possible to allow only members of the Association to become members of the club.

The Committee approved the principle of leaseback with power being retained by the Charity.

- . Mr Bailey thanked all deliverers of the newsletter but added that more were needed.
- . Cllr Goman-Smith proposed a vote of thanks to the Chairman and Committee for their hard work.
